I, _____ (Passenger/diver), hereby affirm that I am a certified diver or a student diver under the control and supervision of a certified scuba instructor, and that I thoroughly understand the hazards of scuba diving including those hazards occurring during boat travel to and from the dive site. I understand that these hazards include, but are not limited to, air expansion injuries, drowning, decompression sickness, slipping or falling while on board, being cut or struck by a boat while in the water, injuries occurring while getting on or off the boat, and other perils of the sea. By signing this release, I certify that I am fully aware of and expressly assume these and all other risks involved in making such a dive or dives, whether conducted as a recreational dive or as part of a diving class.

I understand and agree that neither the divemaster, the crew or owner of the vessel, nor Action Scuba Inc., nor Brockville Dive Charters, nor Gary Davis, nor International PADI Inc., nor TDI Canada, nor the owners, officers, employees, agents, or assigns of the above listed individuals and/or entities (herein-after "Released Parties") may be held liable or responsible in any way for any occurrence on a dive trip which may result in personal injury, property damage, wrongful death or other damage to me or my family, heirs, or assigns that may occur as a result of my participation in a boat trip and scuba dive(s) or as a result of the negligence of any party, including the Released Parties, whether passive or active.

I further state that I am of lawful age and legally competent to sign this liability release, or that I have obtained the written permission of my parent or guardian.

I, _____ (Passenger/diver), BY THIS INSTRUMENT, DO HEREBY EXEMPT AND RELEASE ALL THE ABOVE LISTED ENTITIES AND/OR INDIVIDUALS FROM ALL LIABILITY AND RESPONSIBILITY FOR PERSONAL INJURY, PROPERTY DAMAGE OR WRONGFUL DEATH HOWEVER CAUSED, INCLUDING, BUT NOT LIMITED TO, PRODUCT LIABILITY OR THE NEGLIGENCE OF THE RELEASED PARTIES, WETHER PASSIVE OR ACTIVE.

I ACKNOWLEDGE THAT I HAVE READ THE FOREGOING PARAGRAPHS, FULLY UNDERSTAND THE POTENTIAL DANGERS INCIDENTAL TO ENGAGING IN A BOAT TRIP AND SCUBA DIVE(S), AM FULLY AWARE OF THE LEGAL CONSEQUENCES OF SIGNING THIS INSTRUMENT, AND THAT I UNDERSTAND AND AGREE THAT THIS DOCUMENT IS LEGALLY BINDING AND WILL PRECLUDE ME FROM RECOVERING MONETARY DAMAGES FROM THE ABOVE LISTED ENTITIES AND/OR INDIVIDUALS, WETHER SPECIFICALLY NAMED OR NOT, FOR PERSONAL INJURY, PROPERTY DAMAGE OR WRONGFUL DEATH CAUSED BY NEGLIGENCE OR PRODUCT LIABILITY.

PLEASE REVIEW THE TERMS & CONDITIONS THEN SIGN AND DATE BELOW.

Changes to your dive charter reservation, including cancellation or date changes, may only be made up to 72 hours prior to your scheduled charter date without penalty.

If you need to cancel or postpone your attendance, please do so prior to this deadline. Spots for our dive charter are in high demand, and your early cancellation will give another person the possibility to attend.

We regret that cancellations made within 72 hours of your scheduled charter will be non-refundable and can only be rebooked by purchasing a new dive charter.

Exceptions may be made for documented medical emergencies.

In the event that Action Scuba / Brockville Dive Charters must cancel or reschedule a charter due to extreme weather or unforeseen circumstances, you will receive credit towards another dive charter date of your choosing. You may also request a refund. We will advise you of such a cancellation through the contact information provided at time of booking. We suggest providing a mobile number where you can be reached on the day of the charter.

Our dive charters take place in rain or shine.
